Sanction is hereby accorded to the advance drawal of Rs.10.00 lacs (Rupees Ten lakh only) under Capex Budget 2017-18 in favour of Transport Commissioner J&K, for Implementation of RADMS/GPS in the State.

However, the sanction to advance drawal of the amount shall be subject to the fulfilment of all codal formalities and following conditions:

1. Accounts Officer, Motor Vehicle Department shall vouchsafe availability of funds under relevant head of account.
2. That UCs/Red Accounts of the funds being released shall be furnished to the concerned quarters including Accountant General, J&K.
3. That all codal formalities are fulfilled and reasonability of rates ascertained.
4. No-diversion / re-appropriation of funds from one scheme to another scheme or from one head of expenditure to another shall be allowed in any case.
5. No liability shall be created ensuring financial discipline in the system.
6. That other terms and conditions stipulated in the authorization of Planning Development and Monitoring Department's Government Order No.336-PD of 2017 dated 25-10-2017 shall be adhered and funds utilized for the approved projects only which have prior Administrative Approval and Technical Sanction.


