1. The salary of these officials shall be drawn by the Motor Vehicle Department from the overall Cadre strength of Motor Vehicle Department.
2. DA shall be paid at the rates as was being paid to them as and when the subsequent release of DA shall be applicable to them as and when the same is released by the SRTC.
3. No arrears on account of pay or DA shall be paid in their favour by the Motor Vehicle Department.
4. The officials shall retain lien in their parent organization.

5. The posts vacated by the officials in SRTC shall be deemed to have been frozen and shall not be filled up either by promotion or direct recruitment.
