However, the sanction to advance drawal of the amount shall be subject to the fulfilment of all codal formalities with following conditions:

- 1. Director Finance, Transport Department shall vouchsafe availability of funds under Capex Budget 2016-17 for the purpose.
- 2. Vehicles shall be purchased under replacement programme after completion of all codal formalities and ensuring responsibility of rates properly.
- 3. The allotment of vehicles shall be strictly in accordance with notified car policy of the state.
- No post of drivers shall be created by the department for manning these vehicles.
- 5. Department shall furnish utilization certificate of the authorized advance drawal, well in time, to the concerned quarters.
- 6. No-diversion / re-appropriation of funds from one scheme to another scheme or from one head of expenditure to another shall be allowed in any case.
- 7. No liability shall be created ensuring financial discipline in the system.
- 8. The interest of the department shall be safeguarded against all risks of losses.
