On the following terms and conditions:-

1. The MD J&K SRTC as per attendance certificate of Motor Vehicles Department shall draw the salary of these officials.
2. COLA/DA shall be paid at the rates as was being paid to them in SRTC, the subsequent release of COLA/DA shall be applicable to them as, and when the same is released by the SRTC.
3. No arrears on account of pay or COLA/DA shall be paid in their favour by the Motor Vehicles Department.
4. The officials shall retain their lien in their parent organization.
5. The posts vacated by the officials in SRTC shall be deemed to have been frozen and shall not be filled up either by promotion or direct recruitment.
6. The officials shall be detached to SRTC on the expiry of the terms of attachment.
7. The officials have to submit a bond in the form of an affidavit to the Transport Commissioner, that they will not engage the department in an un-necessary litigation by detaching them back to the J&K SRTC.
