Subject:- Release of differential amount of COLA Slabs in favour of various State Owned PSUs.

In pursuance of Finance Department's authorization conveyed vide O.M No FD-VII (216) PSES/2013 Dated 23.01.2017, sanction is accorded to the release of ₹3,34,90,294 (Rupees Three Crore Thirty Four Lacs Ninety Thousand two hundred ninety four Only) as 4th Instalment along with sanction to the advance drawl of same in favour of MD JKSRTC (as per the Annexure I) for payment to the Ex-Employees of the concerned Corporation on account of differential amount of COLA. However, this authority shall be subject to the following conditions:-

01. Managing Director, J&K SRTC shall certify that no other cases except the ones put up are pending on this account with the corporations.
02. Payment released shall be made by the corporations subject to the verification of genuineness of claims in each individual case.
03. The current release shall be the Fourth instalment to settle the claim of retired employees of the corporation.
04. No budgetary support shall be provided to the Corporations unless to furnish the utilization certificates of all the four instalments.
05. Managing Director, JKSRTC shall ensure that the amount released inclusive of previous releases on this account have been paid to the concerned claimants/ ex-employees of the Corporations, receiving the benefits under VRS/GHS scheme.
