**Subject:-Capex Budget 2016-17- Advance drawal thereof.**

Sanction is hereby accorded to the advance drawal of **Rs.80.00 lacs (Rupees Eighty lakhs only) or actual amount of performa bill, whichever is least** for purchase of (07) seven Maruti Ciaz vehicles for Directors of Planning Development & Monitoring Department and (01) one Ciaz vehicle for Director General Economics & Statistics out of available funds under Capex Budget 2016-17 in favour of Director State Motor Garages .

However, the sanction to advance drawal of the amount shall be subject to the fulfilment of all codal formalities with following conditions:

1. Account Officer, State Motor Garages Department shall vouchsafe availability of funds under Capex Budget 2016-17 for the purpose.
2. That purchase shall be made through State Motor Garages.
3. Vehicles shall be purchased after completion of all codal formalities and ensuring responsibility of rates properly.
4. The allotment of vehicles shall be strictly in accordance with notified car policy of the state.
5. That no post of drivers shall be created by the department for manning the vehicles.
6. That the cost of the vehicle in respect of the Directors should not exceed Rs.9.00 lacs in each case and Rs.10.00 lacs in the case of DG,E&S.
7. Department shall furnish utilization certificate of the authorized advance drawal, well in time, to the concerned quarters.
8. No-diversion / re-appropriation of funds from one scheme to another scheme or from one head of expenditure to another shall be allowed in any case.
9. No liability shall be created ensuring financial discipline in the system.
10. The interest of the department shall be safeguarded against all risks of losses.
