## Notification Srinagar, the 25 th May, 2016

SRO 53 \_\_\_ .- In exercise of the powers conferred by sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), it is hereby published that the Government of Jammu and Kashmir intends to make the following amendments in the Jammu and Kashmir Motor Vehicles Rules, 1991; namely:-

- 1. In rule 80(C), entries (i), (ii) and (iii) shall be substituted by the following:-
- For Light Transport Vehicles. i)

(Goods/Passenger)

Rs. 100/- per day.

For Medium Transport Vehicles. ii)

(Goods/Passenger)

Rs. 150/- per day.

For Heavy Transport Vehicles. iii)

(Goods/Passenger)

Rs. 200/- per day.

- 2. In rule 80, clause (G) shall be recast as under:-In respect of belated application for renewal of all categories of permits, additional fee chargeable shall be as under:
  - Rs. 20/- per day for 45 days and i)
  - ii) Rs. 30/- per day for subsequent days.

Any person who desires to object to the afore-said proposal/amendment may submit his/her objections in writing to the Secretary to Government, Transport Department, Civil Secretariat within a period of six weeks from the date of publication of this notification. Any objection/suggestion received after the expiry of the said period shall not be entertained.
