
**Government Order No. 42-JK (TR) of 2021**  
**Dated: 03-05-2021**

WHEREAS, Mr. Rajinder Singh R/o Harog, District Ramban moved a grievance/compliant during the Hon'ble Lieutenant Governor's Mulaqat Programme on 25-02-2021 with regard to delay in termination of hypothecation deed of his bike bearing Registration No. JK19-5849 in the office of Assistant Regional Transport Officer, Ramban; and

WHEREAS, the Deputy Commissioner, Ramban vide letter No. DC/R/JKLGCC/2021/1698 dated 25-02-2021 has informed that the applicant's file remained pending in the office of Assistant Regional Transport Officer, Ramban for almost one year; and

WHEREAS, vide Government Order No. 18-JK(TR) of 2021 dated 25-02-2021, Shri Mohammad Yousuf Salaria, Conductor, JKRTC Registration No. 2879, deputed in the Motor Vehicle Department (working in the office of ARTO, Ramban during the pendency of grievance of the applicant Shri Rajinder Singh) was placed under suspension, interms of Rule-31 J&K, Civil Services (Classification, Control & Appeal), Rule, 1956 and was attached in the office of Managing Director, JKRTC, J&K, till further orders; and

WHEREAS, vide Government Order No. 19-JK(TR) of 2021 dated 25-02-2021, Shri Pardeep Kumar, KAS, Transport Commissioner, J&K was appointed as Inquiry Officer for conducting in depth inquiry regarding the complaint and delay in redressal of the grievance of Mr. Rajinder Singh R/o Harog, District Ramban and also enquire into the roles and responsibilities and conduct of the delinquent official and to recommended action to be taken against him; and



WHEREAS, the Inquiry Officer vide communication No. TC/JK/MV/Enq/Ramban/821 dated 24-03-2021 submitted Enquiry Report and recommended that the delay in disposal of the case is majorly attributed to Shri Mohammad Yousuf Salaria, then Clerk/Conductor in the office of Assistant Regional Transport Officer, Ramban and has recommended that a compensation of Rs. 5000/- for delay in disposal of the case be imposed on Shri Mohammad Yousuf Salaria and be given to the applicant namely Rajinder Singh R/o Harog, District Ramban, a censure alongwith a warning be also issued to Shri Mohammad Yousuf Salaria, to remain careful in future while disposing off official work.

Now, therefore, in view of the facts elucidated above and with the approval of the Competent Authority, sanction is hereby accorded to the reinstatement of Shri Mohammad Yousuf Salaria, Conductor, JKRTC, Registration No. 2879, with immediate effect alongwith censure in pursuance of the Rule-30 of the Civil Services (Classification, Control & Appeal), Rule, 1956. It is further ordered:-

- i) That a fine of Rs. 5000 is imposed on Mr. Mohammad Yousuf Salaria, Conductor, JKRTC from his salary and same shall be deducted by the concerned DDO of JKRTC and given to Shri Rajinder Singh, R/o Harog, Tehsil and District Ramban for causing to him convenience and mental agony.
- ii) That Shri Mohammad Yousuf Salaria, Conductor, JKRTC, Registration No. 2879 (on deputation to MVD) is hereby repatriated back to his parent organization i.e. JKRTC for further duties.
- iii) That he shall remain careful in future in discharging of his official work without any compliant.
