
Subject: Seniority list of Motor Vehicle Inspector of Motor Vehicle Department- fixation of seniority of Sh. Tara Mani thereof.

**Government Order No. 5 -JK (TR) of 2022**  
**Dated: 24 -01-2022**

**WHEREAS**, on the recommendation of J&K, Service Selection Board, sanction was accorded to the appointment of Sh. Tara Mani, S/o Sh. Tridoo Ram, R/o Ward No. 5, Near Kohli Arms India, Kathua as Motor Vehicle Inspector in the Pay Scale of Rs. 9300-34800 + 4280 (GP) vide Government Order No. 74-TR of 2019 dated 03-12-2019 notionally w.e.f. 01-04-2008 and on regular basis with immediate effect in pursuance of the directions of Hon'ble High Court dated: 02-02-2018, passed in SWP No. 629/2008 C/W SWP No. 110/2007 titled Tara Mani V/s State of J&K and Others read with Order dated 19-11-2018; and

**WHEREAS**, Sh. Tara Mani was appointed as Motor Vehicle Inspector, in relaxation of Jammu and Kashmir Motor Vehicles Rules (Subordinate) Service Recruitment Rules, 1974 by Transport Commissioner, J&K vide order no. 114-TC of 2019 dated 13.12.2019 notionally w.e.f 01.04.2008 and on regular basis with immediate effect, with the condition that the notional appointment of the incumbent would have been made for purpose of fixation of seniority, promotion and pay without payment of arrears on this account; and

**WHEREAS**, vide Government order No: 76-JK(TR) of 2021 dated: 10.12.2021, the seniority of Shri Tara Mani, Motor Vehicle Inspector was fixed at place 18-A of the seniority list of Motor Vehicle Inspector issued vide Government order No: 24-TR of 2011 dated: 25.03.2011 and objections were also solicited from the officials, if

any, feeling aggrieved with the position assigned to Mr. Tara Mani, Motor Vehicle Inspector, within a period of fifteen (15) days from the date of issuance of the Order, failing which the above seniority list would be deemed to have attained finality

**WHEREAS**, no objection has been received within stipulated time or till date, in this regard.

Now, therefore, the seniority of Sh. Tara Mani is fixed at position 18-A of the seniority list of Motor Vehicles Inspector issued vide Government Order No. 24-TR of 2011 dated 25-03-2011 i.e. below Sh. Jamsheed Rasool Chaudhary (S.No.18) and above Sh. Jugal Kishore (S.No. 19).


