**Subject:- Purchase of vehicles for J&K Motor Garages under Capex Budget 2022-23-
Advance Drawal of funds thereof.**

Government Order No. 26 – JK(TR) of 2023

Dated : 20 -03-2023.

Sanction is hereby accorded to the advance drawal of the funds to the tune of Rs.4,31,25,930.00 (Rupees Four crore thirty one lakh twenty five thousand nine hundred thirty) only, out of available funds under Capex Budget 2022-23 in favour of Director, Motor Garages Department for purchase of (41) vehicles on replacement basis as mentioned in the release order under Detailed Head: 115-Works below major Head:4059-Capital Outlay on Public Works, Sub Head:0255-Motor Garages.

The sanction to advance drawal is subject to the following conditions:

1. The Director Motor Garages/Account Officer, J&K Motor Garages shall vouchsafe the availability of funds for the purpose they are meant for.
2. The expenditure shall be booked on admissible items only as approved by the competent authority after observing all the required codal formalities.
3. All the codal formalities as per GFR 2017 shall be followed while incurring Expenditure out of the fund already authorized.
4. The funds shall be utilized for the Specific purpose only without any deviation.
5. UCs/Red accounts of the advance drawal shall be furnished to the concerned quarters within stipulated time.
6. The J&K Motor Garages Department shall make the procurements after following due e-tendering procedures on GeM portal.
7. The Director Motor Garages shall ensure that the advance payment being made after making the advance drawal of the amount is adequately secured and guaranteed.
8. There shall be no idle parking of the amount at all.
9. No post of Driver shall be created.
