Subject: Repatriation of JKRTC employees to their parent organization.

Government Order No. 39-JK(TR) of 2023  
Dated: 19-04-2023

WHEREAS, Sh. Zahoor Ahmad Tantray, Inspector and Sh. Anupam Gandotra, Manager Purchase were deputed to Motor Vehicle Department vide Government Order No. 06-TR of 2018 dated 15.01.2018 and 10-TR of 2018 dated 23.01.2018 respectively;


WHEREAS, deputation of Sh. Zahoor Ahmad Tantray and Sh. Anupam Gandotra was further extended vide Government Order No. 45-TR of 2020 dated 25.08.2020, Government Order No. 03-JK(TR) of 2021 dated 11.01.2021 and finally vide Government order No. 59-JK(TR) of 2021 dated 15.09.2021 upto 31.12.2021, purely on need basis;

WHEREAS, both the deputationists filed OA No. 61/1823/2021 which has been finally disposed of by the Hon'ble Central Administrative Tribunal vide order dated 06.01.2022 directing therein as:-

***"The O.A is disposed of with a direction to the respondents to treat the O.A as a representation and consider claim of the applicant in accordance with rules as well as the judgment of the Tribunal dated 27.07.2021 in T.A No. 657/2021 titled Sikander Singh & ors. V. State of J&K & ors. Within a period of two months from the date of receipt of certified copy of this order by way of reasoned and speaking order with intimation to the applicant."***

WHEREAS, the petitioners had filed the O.A with the prayer for permanent absorption in Motor Vehicles Department which was pari-materia to the prayer made by the petitioners in the case titled Sikandar Singh & ors. Vs. State of J&K & ors in TA No. 657/2021 before the Tribunal i.e the permanent absorption in Motor Vehicles Department;

WHEREAS, Mr. Sikander Singh, Conductor, Regd. No. 2540, was repatriated to his parent Organization i.e JKRTC vide Government order No. 92-TR of 2017 dated 22.11.2017 on his behest and the other petitioners (employees of JKRTC on deputation to Motor Vehicle Department) viz. Mohd Iqbal Bakshi, Makhan Singh, Gurnam Singh, Kavinder Pal Singh, Rohit Kumar and Dinish Singh remained in the Motor Vehicles Department in view of the status-quo orders of the Hon'ble High Court dated 13.02.2015;



WHEREAS, the representation of petitioners in T.A No. 657/2021 and in petitioners (Sh. Zahoor Ahmad Tantray and Anupam Gandotra) in O.A No. 61/1823/2021 were considered in the Department and their prayer of permanent absorption in Motor Vehicles Department is untenable and alien to the service rules jurisprudence;

WHEREAS, the services of all the petitioners (aforementioned employees of JKRTC) were availed in the Motor Vehicles Department on deputation basis.

WHEREAS, sub rule (i) of Rule 52-C of J&K, CSR Volume-I provides as under:-

***"The period of deputation in any case should not exceed three years. It may, however, be extended further by one year on the request of the borrowing agency but in any case the total period of deputation shall not exceed a period of 4 years at a time."***

WHEREAS, all the officials have exceeded their period of deputation beyond 04 years, the prayer of the JKRTC employees is contrary to the J&K Civil Services Rules and is devoid of any merit;

Now, therefore, in view of the facts elucidated above and the prayer having been alien to the rule of deputation as enshrined under Sub Rule (i) of Rule 52-C of J&K, CSR Volume-I, the following officials of JKRTC who are in deputation to Motor Vehicles Department are hereby repatriated to their parent organization i.e JKRTC and are deemed to have been relieved with immediate effect:-


