Sanction is hereby accorded to the appointment of Shri Imtiyaz Ahmad Wani, Director Finance, Transport Department, J&K as "Inquiry Officer" to conduct an in-depth enquiry, regarding delay in completion of the project namely "Institute for Driving, Training and Research (IDTR Jammu)" on the following points: -

1. The Government of India, Ministry of Road Transport & Highways, has sanctioned the project "establishment of IDTR at Ghaink, Kot Bhalwal, Jammu" during the year 2016-17, vide communication No. RT-25036/05/2015-RS dated 30-12-2016 Technical Sanction (TS) was accorded vide Order No.318 dated 16-12-2020.
2. The funds amounting to **Rs. 1014.90 lakhs** has been released by the Ministry of Roads and Highways (MoRTH), GoI, during the year 2019-20.
3. The physical progress of the said project is very low, as a result of which the cost of Project has been escalated due to cost/time over run and the completion of the project has been hampered badly.

The "Inquiry Officer" shall submit the detailed report along-with specific recommendations and cause of delay in execution of the Centrally Sponsored Project to the Administrative Department within one month from the date of issuance of this Government Order. It is further ordered that S. Chand Singh, JKAS, Deputy Secretary to the Government, Transport Department, shall assist the "Inquiry Officer" for conducting the enquiry within stipulated time period.


