SRO<u>253</u>:- In exercise of the powers conferred by Sub-Clause (i) of Clause (d) of Sub-Section (1) of Section 67 of the Motor Vehicles Act, 1988, (Central Act No. 59 of 1988), and in supersession of notification SRO-24 dated 03.02.2014, the Government of Jammu and Kashmir hereby direct the State Transport Authority to fix the maximum chargeable fare in respect of following types of vehicles as per the percentage of fare hike shown against each category:-

i)	Big Buses (Stage Carriages)	13.75%
ii)	Medium/Mini Buses (Stage Carriages)	13.75%
iii)	Taxi/Maxi Cab (Base Model Contract Carriages like; Sumo, Bolero, Tata Indica, Swift, Tata Winger, Tempo Traveler etc.)	8.25%
iv)	Taxi/Maxi Cabs (Medium segment tourist Taxi/Maxi cab contract Carriages like; Tevara, Scorpio, Qualis, Xylo etc.)	8.25%
v)	Taxi/Maxi cabs (Premium class Tourist Taxi/Maxi cab contract Carriages like Innova, Fortuner etc.)	8.25%
vi)	Auto Rickshaw (Petrol Version),	2.85%
vii)	Stage Carriages Viz. Tata Magic (Auto)	13.75%
