**Addendum to Government Order No. 70-TR of 2018
Dated 04-10-2018.**

The following two paragraphs shall and shall always be deemed to have been added after the last paragraph of Government Order No. 70-TR of 2018 dated 04.10.2018:-

"The hiring and de-hiring shall be reckoned from Srinagar for Kashmir Division and from Jammu for Jammu Division. The J&K State Road Transport Corporation will not charge any payment for Recovery Vans and Mobile Workshops.

50% advance payment shall be made to the J&K State Road Transport Corporation by the Chief Electoral Officer, J&K."
