Sanction is hereby accorded to the constitution of Committee headed by Transport Commissioner, J&K in order to conduct in-depth inquiry into the bus accident occurred at Kela Morh, Ramban on 06-10-2018 with following members:-

Terms of reference of Committee are:-

- i) Reasons for bus accident at Kela Morh on 6th October, 2018;
 - ii) Fixing of responsibility, if any , on the official agencies;
 - iii) Measures required to be taken to prevent/reduce the incidence of accidents on the NHW and in the District Doda and Kishtwar including the measures for providing medical aid and evacuation in the event of accident;
 - iv) General suggestion for regulating traffic to ensure smooth movement on the NHW in view of the ensuing fruit season and weather disruptions during the winter season.
- The Committee should complete the inquiry and submit detailed report within seven days.
