Sanction is hereby accorded to the amendment/deletion/restoration/recasting of Rule 6, Rule 7 (i) , Rule 7(ii) and rule 7(iii) of Jammu and Kashmir Road Accident Victim fund Rules, 2019 notified vide Government Order No 02-JK(TR) of 2020 dated 08-01-2020 as under :-

- Rule 6 of the Government Order No. 02-JK(TR) of 2020 dated:- 08-01-2020 deleted vide Government order No: 09-JK(TR) of 2020 dated: 11.02.2020 is restored/recasted as "**0.5% out of 9% of the cost of vehicle as ARM already enhanced vide SRO-492, dated 01-08-2019 on account of Road Tax on new vehicle would be charged as contribution towards Road Accident Victim Fund and the same may be deposited at source in the relevant head as per Rule 7(iii)**".
- Rule 7 (i) is **deleted** from Jammu and Kashmir Accident Victim Fund Rules, 2019.
- Rule 7 (ii) of the Government Order No 02-JK(TR) of 2020 , dated:- 08-01-2020 is recasted as "**Expenditure out of the fund however be made after proper authorization from Finance Department as per the requirement from time to time**".
- Rule 7(iii) is recasted as "**Funds shall be classified under Major Head:8235-General and other Reserve Fund , Minor Head:200-Other Funds and Sub-Head:2309-Passenger welfare Fund**".


