In continuation to Government Order No. 27-JK(TR) of 2020 dated 07-06-2020, Government Order No. 36-JK (TR) of 2020 dated 05-08-2020 and in conjunction with Government Order No. 74-JK(DMRRR) of 2020 dated 04.08.2020 issued by Chairperson, State Executive Committee, the below mentioned routes are hereby notified for plying of buses and mini-buses:-

- 1. Jammu to Doda and vice-versa.
- 2. Jammu to Bhaderwah and vice-versa.
- 3. Jammu to Kishtwar and vice-versa.
- 4. Jammu to Paddar and vice-versa.

Provided that no passenger/driver/conductor shall be allowed to disembark from/board the bus/mini-bus while travelling through the territorial jurisdiction of district Ramban (Red District).

The buses and mini-buses (stage and contract carriage vehicles) plying on the aforementioned routes shall carry passengers not more than 50% of their authorised seating capacity in case of 2x2 seater buses/mini-buses and $2/3^{rd}$ (two third) of their authorised seating in case of 3x2 seater buses.

All the instructions enshrined in the SOP notified vide Government Order No. 27-JK(TR) of 2020 dated 07-06-2020 have to be followed in letter and spirit while operating the public transport. Any deviation shall attract action as envisaged in the Government Order No. 61-JK (DMRRR) of 2020 dated 07-06-2020 of the Chairperson, State Executive Committee.
