WHEREAS, Mr. Rajinder Singh R/o Harog, District Ramban moved a grievance/compliant during the Hon'ble Lieutenant Governor Mulaqat Programme on 25-02-2021 with regard to delay in termination of hypothecation deed of his bike bearing Registration No. JK19-5849 in the office of Assistant Regional Transport Officer, Ramban; and

WHEREAS, the Deputy Commissioner, Ramban vide letter No. DC/R/JKLGGC/2021/1698 dated 25-02-2021 informed that the applicant's file remained pending in the office of Assistant Regional Transport Officer, Ramban for almost one year; and

WHEREAS, vide Government Order No. 17-JK(TR) of 2021 dated 25-02-2021, Shri Chander Mohan Sharma, Motor Vehicle Inspector, posted in the office of Assistant Regional Transport Office, Ramban was placed under suspension, interms of Rule-31 J&K, Civil Services (Classification, Control & Appeal), Rule, 1956 and was attached in the office of Transport Commissioner, J&K; and

WHEREAS, vide Government Order No. 19-JK(TR) of 2021 dated 25-02-2021, Shri Pardeep Kumar, KAS, Transport Commissioner, J&K was appointed as Inquiry Officer for conducting in depth inquiry regarding the complaint and delay in redressal of the grievance of Mr. Rajinder Singh R/o Harog, District Ramban and also enquire into the roles and responsibilities and conduct of the delinquent official and to recommended action to be taken

against him; and

WHEREAS, the Inquiry Officer vide communication TC/JK/MV/Enq/Ramban/821 dated 24-03-2021 submitted Enquiry Report though did not recommend any kind of action against Shri Chander Mohan Sharma, Motor Vehicle Inspector, but from the status downloaded from Vahan Portal and report of the Deputy Commissioner, Ramban, it is discernible that delay in processing the case of the applicant is also attributable to Motor Vehicle Inspector also.

Now, therefore, in view of the facts elucidated above and with the approval of the Competent Authority, sanction is hereby accorded to the reinstatement of Shri Chander Mohan Sharma, Motor Vehicle Inspector in consonance with the provisions of the Rule-31 (3) of the Civil Services (Classification, Control & Appeal), Rule, 1956 with immediate effect alongwith warning to remain careful in future and dispose off the official work without any complaint.
