Dated : 10 -08-2021

Sanction is accorded to the release of Rs.3.20 crore (Rupees Three Crore Twenty Lakh) only out of the Capex Budget 2021-22 in favour of Director State Motor Garages Department together with advance drawal of the equivalent amount for purchase of 20 vehicles for Chairperson of each DDCs within the cost of Rs 16.00 lakh (Rupees Sixteen Lakh) only.

However, the sanction to release of amount alongwith advance drawal shall be subject to the following conditions:

- i) The vehicles shall be purchased within the Cost of Rs 16.00 lakh each. Mostly economical & efficient vehicles may be purchased, not necessarily high end models not suitable for the topology.
- ii) The Custody of vehicles shall remain with the State Motor Garages Department.
- iii) The purchase is made after ascertaining reasonability of rates as most economical.
- iv) All the required provisions GFR shall be followed in letter & spirit.
- v) Red Account against the Advance drawal be submitted to the Accountant General's office within stipulated time.
- vi) The purchase does not involve creation of post of drivers.
- vii) The fuel for these vehicles shall be provided by Security Wing of J&K Police.
