In reference to subject cited above, sanction is hereby accorded to the release of funds amounting to Rs. 1067 Lakhs (Rupees Ten crores sixty seven lakhs only) and its advance drawl by Director Finance, Transport Department out of Deposit Head: 8443-Civil Deposit, Minor Head: 111-Other Department Deposits for further placement at the disposal of Transport Commissioner for its utilization for the following items of Revalidated Action Plan under Road Safety Fund Rules, 2018:-

Setting up of RADMS Control Room infrastructure and cabins for Rs. 18.50 Lakh.

Expenses on account of Registration of vehicles (110 bikes, 7 cranes, 3 interceptor vehicles already purchased besides 213 motorcycles, 20 mobile vehicle interceptors and 26 cranes proposed for this year for Rs. 128.00 Lakhs.

3. Purchase of High Tech body worn cameras or other enforcement equipments as deemed absolutely necessary for the effective implementation of road Safety measures within the budgetary provision for Rs.

4. Purchase of 20 No's of mobile vehicle interceptors (one for each District) and the required equipments to be fitted into these vehicles for increasing mobility on State and National Highways as per directions of the Hon'ble Supreme Court Committee on Road safety for Rs. 584.00 Lakhs.

Purchase of Motor Cycles one each to the 213 Police Stations in J&K being first responders in case of Road Accidents and also for uploading of live Road Accident Data on RADMS App being used by the Transport

Department for Rs. 311.00 Lakh

However, the funds so drawn in advance and placed at the disposal of Transport Commissioner for its utilization on the approved items of Revalidated Action Plan be utilized subject to the following terms and conditions:

The Transport Commissioner/ HoD Concerned/DDO shall vouchsafe the availability of funds as per

· codal provisions.

The HoD Concerned/DDO shall utilize the funds after ensuring strict compliance of all due procedures as prescribed under GFR and Manual of procurement of Goods and Services.

The HoD concerned/DDO shall make the procurements after following due bidding procedures on GeM Portal.

The amount shall be utilized as per approved items of revalidated Action Plan within timeline prescribed and shall not be parked unnecessarily in the Bank accounts.

The expenditure shall be incurred after obtaining approval from the competent authority.

- The HoDs concerned shall ensure the completion of the proposed projects ensuring Road Safety measures within the timeline stipulated by the Road safety Fund Management Committee.
- 7. Transport Commissioner shall further place the funds at the disposal of concerned HoDs for its utilization as per items approved in the Revalidated Action Plan.

The Red DC Account of the advance drawl/funds released shall be furnished to the Accountant

General within stipulated time but before 31.03.2022.

Transport Commissioner shall coordinate with all concerned HoDs for successful implementation of approved items of the Action Plan and furnishing of Red Account to the Administrative Department/Accountant General within prescribed time.
