WHEREAS, the notional appointment of Sh. Tara Mani was made in relaxation of Jammu and Kashmir Motor Vehicles Rules (Subordinate) Service Recruitment Rules, 1974 with the conditions that the notional appointment has been made for purpose of fixation of seniority, promotion and pay without payment of arrears on this account; and

WHEREAS, the Transport Commissioner, J&K vide letter No. TC/JK/Esttb/285P/205 dated 08-02-2021 has requested to fix the seniority of Sh. Tara Mani, Motor Vehicle Inspector in the seniority list of Motor Vehicle Inspector at appropriate place; and

WHEREAS, vide Government Order No. 24-TR of 2011 dated 25-03-2011 the Administrative Department has notified the final seniority list of Motor Vehicle Inspectors (Technical & Survey); and

WHEREAS, the case was examined in the Department and vide this Department's letter No. TR-14/MVD/2021 dated 01-03-2021, the J&K, Service Selection Board was requested to furnish the merit list of Motor Vehicle Inspector (Technical & Survey) Transport Department under State/Divisional Cadre vide Advertisement Notification No. 10 of 2005 dated 29-05-2005; and

WHEREAS, the J&K, Service Selection Board vide letter No. SSB/T-3/08/Secy/3256-57 dated 26-03-2018 and letter No. SSB/Sel/Secy/08/2957 dated 25-03-2021 has furnished the merit list of selected candidates for the post of Motor Vehicle Inspector (Technical & Survey) Transport Department under State/Divisional Cadre vide Advertisement Notification No. 10 of 2005 dated 29-05-2005; and

WHEREAS, as per the merit list furnished by the J&K, Service Selection Board, the merit position of Sh. Tara Mani falls above Sh. Jugal Kishore and below Sh. Jamsheed Rasool Chaudhary; and

Whereas, after considering Sh. Tara Mani in the seniority list notified vide Government Order No. 24-TR of 2011 dated 25-03-2011, his seniority position emerged as:-

In view of the above and by adhering to the principle of natural justice, the seniority of Sh. Tara Mani (MVI) is fixed at place 18-A of the seniority list of Motor Vehicles Inspector issued vide Government Order No. 24-TR of 2011 dated 25-03-2011 i.e. below Sh. Jamsheed Rasool Chaudhary (S.No.18) and above Sh. Jugal Kishore (S.No. 19).

In case, any official feels aggrieved with the position assigned to him, he/she may file objection, if any, containing the facts, as have come to the light now and which have a material bearing on the issue of determination of seniority of Motor Vehicle Inspectors of Motor Vehicle Department, should reach Administrative Department, Civil Secretariat, within a period of fifteen (15) days from the date of issuance of this Order, failing which the above seniority position assigned to Shri Tara Mani (MVI) shall be deemed to have attained finality.
