Finance Department vide eUO No FD-BDGT0D/29/4/2021-03-FD dated 30.11.2021 has conveyed its concurrence to the creation of Corpus Fund of Rs. 100.00 lakh (Rupees one crore only) under Major Head: 8235-General and other Reserve Funds, Minor Head: 200-Other Funds, Sub Head: 3350-J&K Road Accident Victim Fund by corresponding debit to expenditure Major Head: 2041-Taxes on Vehicles, Sub Major Head: 00-NA, Minor Head: 797-Transfer to/From reserve funds and Deposit Accounts, Group Head: 0099-General, Sub Head: 3350-J&K Road Accident Victim Fund, Detailed Head: 032-Relief & Rehabilitation.

Finance Department also conveyed that the funds of Rs. 100.00 lakh (Rupees one crore only) have been re-appropriated to supplement the expenditure head: 29-2041-00-797-0099-3350 vide Government Order No. 302-F of 2021 dated 15.11.2021, for its further contra credit to MH: 8235-200-3350 (J&K Road Accident Victim Fund).

**Accordingly, Sanction is hereby accorded to the creation of Corpus Fund of Rs. 100.00 lakh (Rupees one crore only) under Major Head: 8235-General and other Reserve Funds, Minor Head: 200-Other Funds, Sub Head: 3350-J&K Road Accident Victim Fund by corresponding debit to expenditure Major Head: 2041-Taxes on Vehicles, Sub Major Head: 00-NA, Minor Head: 797-Transfer to/From reserve funds and Deposit Accounts, Group Head: 0099-General, Sub Head: 3350-J&K Road Accident Victim Fund, Detailed Head: 032-Relief & Rehabilitation and Sanction is also accorded for further contra credit of Rs. 100.00 lakh re-appropriated to supplement the expenditure head: 29-2041-00-797-0099-3350 to MH: 8235-200-3350 (J&K Road Accident Victim Fund).**

However, creation of Corpus Funds & expenditure out of it shall be made subject to the following conditions:

1. The main source of the J&K Road Accident Victim Fund shall be the same as per State Administrative Council (SAC) Decision No. 161/17/2019 dated 03.07.2019 according to which a value of 0.5% of the cost of vehicle to be charged at the time of registration of new vehicles, may be deposited at source into Major Head: 8235-200-3350 as contribution towards Road Accident Victim Fund.
2. All the receipts and payments shall directly be made through the Fund (Major Head: 8235-200-3350) and the Department shall ensure the reconciliation of balances regularly as per the codal provision.
3. The expenditure out of the Fund shall be made after proper authorization from the Finance Department as per the requirement from time to time.
4. The Department, after the close of every financial year, shall contra credit the surplus amount, if any accumulated over and above Rs. 4.00 crore ( Rupees four crore only) at the credit of Road Accident Victim Fund under Major Head: 8235-200-3350, to revenue/receipt head of the Department after proper reconciliation with concerned Treasury and with prior authorization of Finance Department.
5. The payment of relief out of the Fund shall be made to the NoK(s) of the Road Accident Victim through DBT mode.
