**Government Order No. 08 -JK (TR) of 2022**

Sanction is hereby accorded to the registration of the vehicles older than 15 years of age, in the UT of J&K in general and twin capital cities of Jammu and Srinagar in particular subject to the realization of road/token tax applicable to different categories of vehicles under the explicit provisions of Jammu and Kashmir Motor Vehicle Taxation Act, 1957 and SROs/S.Os issued by the Government from time to time, in following manner:-

- a) To begin with, all Commercial vehicles shall be phased out after 20 years in non-attainment cities i.e. Jammu and Srinagar.
- b) All commercial vehicles in other areas shall be phased out after 25 years as per current norms of fitness certificates every six months as per orders of Hon'ble High Court after its initial period.
- c) All private personal vehicles shall be allowed to ply as per fitness certificates.




