Ten crore fourteen lakh only) and its advance drawl by Director Finance, Transport Department out of Deposit Head 8443-Civil Deposit, Minor Head 111-other Departmental Deposits, for further placement at the disposal of Transport Commissioner J&K for its utilization for implementing the following component wise activities of the Approved Action Plan 2021-22 for Road Safety measures:-

- Retrofitting for 110 Bikes Royal Enfield 350 Classic and three Interceptor Vehicles procured during the FY 2018-19: Rs.50.000 lakh.
- 2. Purchase of 26 cranes: Rs.442.00 lakh.
- 3. Purchase of 16 No. Highway Patrolling vehicles i.e Innova Vehicle including Retro-fitting & Fabrication Cost+AMC (3 years) + Registration Charges: Rs.370.00 lakh.
- 4. Procurement of Traffic Equipments: Rs.152.00 lakh .

However, the Funds so drawn in advance and placed at the disposal of Transport Commissioner for its further utilization subject to the following terms and conditions:

- Transport Commissioner/Concerned DDO shall vouchsafe the Availability of funds as per codal provisions.
- The HoD concerned/DDO shall utilized the fund after ensuring strict compliance of all due procedures as prescribed under GFR and Manual of procurement of Goods and Services.
- 3. The HoD concerned/DDO shall make the procurements after following due bidding procedure on GeM Portal.
- The amount shall be utilized for implementing component wise activities of the Approved Action Plan 2021-22 and shall not be parked unnecessarily in the Bank Account.
- 5. The HoD concerned shall ensure the completion of proposed projects ensuring Road Safety Measures within the timeline stipulated by the Road safety Full Management Committee.
- 6. Transport Commissioner shall further place the funds at the disposal of concerned HoDs for its utilization as per items approved in the Action Plan.
- 7. Transport Commissioner shall coordinate with all concerned HoDs for successful implementation of the approved items of the action plan and furnishing of Red Account to the Administrative Department/Accountant General within prescribed time.
