7. The funds shall not be available for re-appropriation or diversion/deviation at any level and it must be ensured that there shall be no idle parking of funds at all.

8. The UC's/Red DC account of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31-03-2022.
