The deputation of these officials is subject to the following terms and conditions:-

- i. The salary of these officials shall be drawn by Motor Vehicles Department against the vacant posts in Motor Vehicles Department.
- ii. DA shall be paid to the deputationist at the rates as was paid to them in their parent organization (JKRTC) and subsequent release of DA shall be applicable to the deputationist as and when the same is released by the JKRTC.
- iii. No arrears on account of pay or DA shall be paid to the deputationist by the Motor Vehicles Department.
- iv. The salary in favour of these officials shall be released from the date they join their duties in Motor Vehicles department.
- v. The officials shall retain lien/promotion prospects in their parent organization i.e. JKRTC.
- vi. The posts vacated by the Officials in JKRTC shall be deemed to have been frozen and shall not be filled up either by promotion or direct recruitment; and
- vii. These officials shall be reverted to JKRTC on the expiry of the terms of deployment.

It is further ordered that the services of above deputationists be utilized in the Districts of Anantnag, Ramban and Poonch.
