Sanction is hereby accorded to the Accord of Administrative Approval for **Macadamization of open area after raising of ground level upto road level at JKRTC Yard, Bikram Chowk Jammu** at an estimated cost of Rs. 212.90 lakh (Rupees Two Crore Twelve lakh and ninety thousand) only under Capex Budget 2022-23.

The Administrative Approval is subject to the following conditions:-

1. That all the codal / procedural formalities as per GFR shall be followed while executing the work, funds under relevant head of expenditure are available and work/ project has been approved in the Capex Budget.
2. Rs 12.90 lacs over and above Rs 200.00 lakhs approved under Capex Budget 2022-23 shall be met from the internal resources of Corporation.
3. That there shall be no time or cost overrun involved in the work and set time line adhered to. No cost escalation shall be admissible in any circumstances.
4. That Physical / Financial achievement shall be submitted to the Administrative Department by or before 5th of every month.
5. That the actual construction/work shall be taken up only after accord of technical sanction by the competent authority.
6. That the encumbrance free land is available for the execution of work.
7. That the proposals are strictly devised and designed as per latest relevant I.S codes and specification of PWD/CPWD and same is authenticated and proof checked by the competent authority. While designing, latest Highest Flood Level has to be taken into consideration for flood prone locations and adequate provisions adequate provisions in design need to be incorporated for making the structures resistant to earthquakes.



8. That the standard specifications are to be followed as per DPR approved by competent authority.

9. Work shall be tendered as per provisions contained in the GFR.


