Whereas, on the recommendation of the J&K Service Selection Board, the General Administration Department vide O.M. No. GAD/MTGORBIV/267/2022-09-GAD dated 27.10.2022 forwarded the selection list of (07) candidates for the post of Multi Tasking Staff (Class-IV) and vide Government Order No. 59-JK (TR) of 2022 dated 31.10.2022 appointment order was issued by the department; and

Whereas, one employee namely Mr. Khalid Ahmad Wani S/o Mr. Gh. Mohammad Wani R/o Lalipora, Malapora, Anantnag joined on 03.11.2022 and subsequently submitted his resignation in the Directorate of State Motor Garages Department on 28.11.2022; and

Whereas, the Director, State Motor Garages Department, J&K vide letter No. RCD-726/4625-27/DSMG dated 06.12.2022 has forwarded the tendered resignation of Mr. Khalid Ahmad Wani to this department for accord of necessary sanction to the acceptance of his resignation w.e.f. 28.11.2022 (AN) from the post of Multi Tasking Staff (Class -IV); and

Whereas, Mr. Khalid Ahmad Wani was appointed on temporary basis and was on probation for a period of 02 years under the provisions of S.O. 192 of 2020 dated 17.06.2020; and

Whereas, the case of resignation tendered by Mr. Khalid Ahmad Wani, MTS got examined in the department in light of Rule-21(1) of Jammu & Kashmir Civil Services (Classification Control and Appeal) Rules, 1956 which reads as under:

21(1) At any time before the expiry of the prescribed period of probation, the appointing authority may:

a. Suspend the probation of a probationer and discharge him from the service for want of vacancy; and



b. At its discretion terminate the probation of a Probationer and discharge him from the service.

Now, therefore, in terms of J&K Civil Services (Classification Control and Appeal) Rules, 1956 and on the recommendation of Director, State Motor Garages Department, J&K, the resignation of Mr. Khalid Ahmad Wani, Multi Tasking Staff (Class-IV) S/o Mr. Gh. Mohammad Wani R/o Lalipora, Malapora, Anantnag is accepted and he is discharged from the J&K State Motor Garages (Subordinate) Services w.e.f. 28.11.2022 (AN).
