Subject: Representation of Mr. Swaran Singh, JKAS, regarding ante-date promotion into the Time Scale of JKAS-fixation of seniority as ARTO thereof.

**Government Order No. 37-JK (TR) of 2023**  
**Dated: 06-04-2023**

**WHEREAS,** on the recommendation of the J&K, Public Service Commission /Departmental Promotion Committee, vide Government Order No. 47-TR of 2019 dated 09-07-2019, Mr. Swaran Singh, I/c ARTO was regularized as Assistant Regional Transport Officer in the Motor Vehicles Department in the Pay Scale of Rs. 9300-34800+GP=4800 (pre-revised) 47600-151100 with effect from **08-02-2008**; and

**WHEREAS,** the final seniority list of ARTOs of J&K, Transport (Gazetted) Service, as it stood on 01-01-2010 was issued vide Government Order No. 80-TR of 2010 dated 24-12-2010. The said seniority list was issued before the regularization of Mr. Swaran Singh, thereafter, no seniority list of ARTOs of Transport (Gazetted) Service has been notified/issued till date; and

**WHEREAS,** Mr. Swaran Singh, JKAS approached the General Administration Department with the plea that he may be given the effect of induction ante-date and the General Administration Department vide O.M. No. GAD-SERVOKAS/90/2021 dated 08-12-2022 advised this Department to notify the seniority list of the officers of the Jammu and Kashmir Transport (Gazetted) Service and to clarify after finalization of seniority list, any impact on the position of Mr. Swaran Singh viz-a-viz his juniors and his induction in JKAS from 01-01-2019; and

**WHEREAS,** vide Government Order No. 11-JK(TR) of 2023 dated 16-02-2023, , the seniority of Mr. Swaran Singh as ARTO was fixed at **8-A** in the final seniority list issued vide Government Order No. 80-TR of 2010 dated 24-12-2010 i.e. above Mr. V.K. Manyal (SC Category) and below Mr. Manzoor Ahmed on the grounds that Mr. Swaran Singh has been regularized/promoted as ARTO on 08-02-2008 (vide Government Order No. 47-TR of 2019 dated 09-07-2019) i.e. prior to Mr. V.K. Manyal (SC Category) was appointed as ARTO on 04-04-2008 under direct

recruitment quota through J&K Combined Competitive Examination and objections were also solicited from the officials, if any, feeling aggrieved with the position assigned to Mr. Swaran Singh, as ARTO, within a period twenty one days (21) from the date of issuance of the Order and no objection has been received within a stipulated time or till date

Now, therefore, the seniority of Mr. Swaran Singh as ARTO is fixed at position **8-A** in the final seniority list issued vide Government Order No. 80-TR of 2010 dated 24-12-2010 i.e. above Mr. V.K. Manyal (SC Category) and below Mr. Manzoor Ahmed.
