However, the seniority of all the appointees whose selection has been recommended by the J&K Services Selection Board vide letter No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022 in Transport Department (State Motor Garages Department) shall be determined in terms of their merit in the selection list issued by the J&K Services Selection Board.

The appointee namely Mr. Susheel Kumar S/o Ram Lal R/o Sunetar, Tehsil Ramnagar, District Udhampur shall report to the Director, J&K State Motor Garages Department, within a period of twenty one (21) days from the date of issuance of this order and in case the appointee fails to join within the stipulated time, he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:

- I. Academic/Qualification Certificate.
- II. Matriculation/Date of Birth Certificate.
- III. Health Certificate from the concerned Chief Medical Officer of the District.
- IV. Domicile Certificate issued by the Competent Authority.
- V. Valid relevant Category Certificate, if any, applicable.

The appointment of the above candidate shall further be subject to the following conditions:

a. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Reserved Category Certificate from the concerned issuing authorities is found fake/forged, his appointment as Multitasking Staff (MTS) in the J&K State Motor Garages Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

- b. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
 - c. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/encerprise and also stakes, if any, in such self-employment unit/enterprise before joining the government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and also personally monitor its recovery.
 - d. The appointee shall furnish an Undertaking in the shape of an Affidavit as per Annexure-A to this Order.
 - e. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/ Date of Birth/ Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.
 - f. The appointee shall be on probation for a period of two years.
 - g. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
 - h. The inter-se-seniority of the appointee in the J&K State Motor Garages Department shall be determined as per the J&K Civil Services(Classification, Control and Appeal) Rules, 1956.
 - i. The appointment of the above appointee shall be cancelled abinitio, if it is found that he possess higher qualification than the prescribed one at any stage and he shall also be liable for criminal prosecution under law.

The appointment of the above appointee shall be subject to j. outcome of writ petition(s), if any, pending before Competent Court of law.
