7. That the encumbrance free land is available for the execution of work.

8. That the proposals are strictly devised and designed as per latest relevant I.S codes and specification of PWD/CPWD and same is authenticated and proof



checked by the competent authority. While designing, latest Highest Flood Level has to be taken into consideration for flood prone locations and adequate provisions in design need to be incorporated for making the structures resistant 9. That the standard specifications are to be followed as per DPR approved by
