Sanction is hereby accorded to the release of additional funds amounting to **Rs. 498.80 lakh (Rupees four crore, Ninety eight lakh and Eighty thousands)** only along with advance drawl under Detailed Head: 115-Works below MH: 4059-Capital Outlay on Public Works , Sub Head: 0255- Motor Garages and its placement thereof at the disposal of Director , Motor Garages J&K for **purchase of 21 new vehicles as per details given below :-**

Sanction is also accorded to the purchase of High-end Cars for " to be elected Hon'ble Minister" etc. (including Hon'ble Chief Minister) in Relaxation of Car Policy.

However, the above sanction shall be subject to the following conditions.:

- 1. FA/CAO of the State Motor Garages (SMG) shall vouchsafe the availability of funds for the purpose they are meant for.*
- 2. The Department / SMG shall utilize the funds after fulfilment of all the codal formalities and after following due e-tendering process as per Manual of Procurement of Goods and GFR stipulations.*

3. *The funds shall not be available for re- appropriation or diversion/deviation at any level and it must be ensured that there shall be no idle parking of funds at all.*
4. *No post of Driver shall be created.*
5. *The UC's of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31-03-2025.*
6. *The SMG shall reflect the additionality in the RE 2024-25.*


