Government Order No. 13 -JK(TR) of 2025 Dated: 20 .02.2025

Sanction is hereby accorded to the temporary appointment of Ms. Maryam Farooq D/o Late Farooq Ahmad Mir (Ex-Senior Assistant), State Motor Garages Department R/o Choora, Baramulla as Multitasking Staff (MTS) in the Pay Level SL-1(14800-47100) in State Motor Garages Department, J&K, under Jammu & Kashmir Rehabilitation Assistance Scheme-2022 notified vide S.O 429 dated 06.09.2022 read-with S.O. 397 dated 16.08.2024.

The appointee shall report to the Director, State Motor Garages Department, J&K within a period of twenty one (21) days from the date of issuance of this order, failing which she shall forego her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

Academic/Qualification Certificates.

Matriculation/Date of Birth Certificate.

Health Certificate from the concerned Chief Medical Officer of iii. the District.

Domicile Certificate issued by the Competent Authority. iv.

Valid relevant Category Certificate, if any applicable. v.

The appointment of the above candidate shall further be subject to the following conditions:

- Affidavit to the effect that, if on verification, her qualification/Date of Birth/Category certificate, if any, from the concerned issuing authority are found to be fake/forged, the claim of the appointee for appointment as Multitasking Staff (MTS) shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against her.
- b. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, she shall relinquish the proprietorship of unit/enterprise before joining the Government Service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- C. That the appointee shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate First Class, to the effect that the applicant is unemployed as on date and none of the family members other than the applicant has taken benefit of compassionate appointment under Jammu & Kashmir Rehabilitation Assistance Scheme-2022. In case it turns out that the applicant is already appointed or the benefit of compassionate appointment under RAS-2022 has been already extended to the family of the deceased, then the instant appointment shall be deemed to have been withdrawn ab-initio without any further notice.
- d. The appointee shall furnish an Undertaking in the shape of an Affidavit as per **Annexure-A** to this Order.
- e. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of genuineness of Qualification/Date of Birth/Category Certificate, if any, is received from the concerned Authorities.



- f. The appointee shall be on probation for a period of two years.
- The appointment of the candidate shall be governed by the "New Pension Scheme' as notified vide SRO-400 of 2009 dated 24.12.2009.
- h. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
