Pursuant to the recommendations of J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of Mr. Mohd Asif Wani S/o Wali Mohd Wani R/o Tarahama Makdam Mohalla, Kawarhama, Baramulla under Open Merit Category, as Works Manager in the Pay Level SL-8A(50700-160600) in State Motor Garages Department, J&K.

The appointee shall report to the Directorate of State Motor Garages Department, J&K within a period of twenty one (21) days from the date of issuance of this order and shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:

- Qualification Certificates.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate issued by the Competent Authority.
- iv. Valid relevant Category Certificate, if any applicable.
- v. Health Certificate from the concerned Chief Medical Officer of the District.
- vi. Any other certificate required under rules.

In the event of failure to join within a period of 21 (twenty one) days from the date of issuance of the appointment order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further Notice.

The salary of the appointee shall be drawn and disbursed to him after the receipt of the satisfactory reports in respect of genuineness of qualification/Date of Birth/Relevant category certificates, if any, and subject to production of an affidavit (as per Annexure-I) to this order. In case, the candidate is adversely reported upon by the verifying agency or any certificate is found not to be genuine/valid, he shall have no claim to hold the post to which appointed and his appointment shall automatically stand cancelled without any further notice.

The appointee shall be on probation for a period of two years.

If the appointee has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.

The inter-se-seniority of the appointee in the J&K Motor Garages Department shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
