Subject: Amendment in Jammu & Kashmir Transport (Gazetted) Service Recruitment Rules-inviting objections thereof.

The Jammu and Kashmir (Gazetted) Service Recruitment Rules, were updated and notified vide SRO 289 dated: 14th July, 2017 and the qualification for the departmental promotion candidate has not been mentioned which was earlier mentioned in the Jammu and Kashmir Transport (Gazetted) Service Recruitment Rules notified vide SRO 70 dated 10th February, 1987. To bring more clarity, the Department intend to amend Schedule-II of Jammu and Kashmir (Gazetted) Service Recruitment Rules, 2017 notified vide SRO 289 dated: 14th July, 2017 by incorporating the qualification column for the departmental candidates after the qualification for direct recruitment column against the post of Assistant Regional Transport Officer/ Assistant Transport Commissioner in following manner:-


